

Virtual Open Industry Sessions

October 14 and 15, 2020

The biannual Open Industry Sessions, previously organized by Canadian Dairy Network (CDN), have served well as a means of communicating research results and proposed improvements to genetic evaluation services in Canada as well as for seeking input from industry partners and producers able to attend. The main purpose of these Open Industry Sessions has been to assist members of the Genetic Evaluation Board (GEB) in terms of making recommendations for approval by the CDN (now Lactanet) Board of Directors prior to implementation.

One outcome of the current Covid-19 pandemic is that many organizations, including Lactanet, have learned to conduct business and meetings virtually rather than face-to-face. This experience has now led to the decision to transition the format of these Open Industry Sessions to a virtual format using Zoom, which provides the opportunity for producers and industry personnel across Canada to participate.
